We will arrange to provide the following forms of Planned Giving: bequests, cash, securities, life insurance, IRAs, real estate, charitable remainder (unitrust, annuity trust, lead trust)

To Grow Bequests

Consider leaving a bequest to USA Fencing and/or the US Fencing Foundation by naming either organization as a beneficiary in your will or trust.

What is a Bequest?

A bequest is a gift you make to USA Fencing and/or the US Fencing Foundation through your will or trust, which indicates your desire to leave something of value toward USA Fencing and/or the US Fencing Foundation's future work. A charitable bequest can be specific dollar amount or percentage of the value of your total estate, a gift of stock, life insurance or even real estate.

Donors wishing to designate a gift to USA Fencing and/or US Fencing Foundation in their will or trust should use the following language:

"I wish to give (choose the appropriate statement): a specific dollar amount; percentage of the estate; or (specific number) of shares of (specified) security security to USA Fencing and/or the United States Fencing Foundation, 210 USA Cycling Point, Suite 120, Colorado Springs, CO 80919, Attention: Development Department – Planned Giving. Savings or Retirement Accounts

Naming USA Fencing and/or the US Fencing Foundation as a beneficiary can be accomplished without an attorney. Simply contact your IRA custodian, bank or insurance representative for a beneficiary designation form. Should you decide to change your mind regarding beneficiary designations, the document can easily be updated to reflect changes.

Use of Gifts

USA Fencing and/or the US Fencing Foundation works closely with you to identify the purpose within our organizations that most closely meets your interests for Planned Giving. You may specify a purpose for your gift in alignment with your giving priorities.
